Re: Open Records Act Request

Dear Mr. King;

I am in receipt of your second Open Records Act requested dated July 28, 2009. Upon receipt of your request via email I phoned you to discuss your request. At that date, I explained to you that I was recuperating from emergency surgery and would respond to your request during the week of August 3, 2009. I sent a follow up email to this effect. That email is attached to this documentation.

As for your requests, I will take them in turn.

1. You request all documents, including emails, between my office and any and all other employees or board members related to TCSG compliance with existing federal and state laws regarding administration of Federal and State and Local Public Benefits. In that same vein you requested any documents or email traffic pertaining to the recent news coverage of your intent to initiate a lawsuit.

There are approximately 350 pages responsive to this request and this request took 4 administrative hours to collect. The charge is \$.25/page and \$10 per administrative hour for a total of \$127.50.

2. You also request copies of all Technical College admissions applications, applications for Adult Education, ESL classes and a sample of the state required affidavit from all applicants for Public Benefits. Additionally, you requested a sample copy of all applications offered by all Georgia Technical Colleges for federal or state funded student loans or grants.

There are approximately 250 pages responsive to this request and this request took 4 administrative hours to collect. The charge is \$.25/page and \$10 per administrative hour for a total of \$102.50.

- 3. Your third request is a copy of the Memorandum of Understanding with the US Department of Homeland Security authorizing TCSG to use SAVE. Because the requirement to collect affidavits from adult education students and run them through SAVE is not required until January 1, 2010, there are no documents responsive to your request.
- 4. Documents responsive to your fourth request were combined with documents responsive to your second request.
- 5. Your fifth request is for a copy of the memorandum of Understanding with the United States Department of Homeland Security from TCSG's Human Resources Department for use of the federal E-Verify database.

There are 6 pages responsive to this request and this request took 1 administrative hours to collect. The charge is \$.25/page and \$10 per administrative hour for a total of 11.50.

6. Your sixth request is for copies of all documents listing all legal firms and representation used by TCSG as legal consul [sic] to defend against litigation/civil lawsuits and all documents indicating agreed upon hourly fees to said consul [sic].

There are no documents responsive to this request.
